

**MINUTES**  
**Twin Lakes Township**  
**Wednesday, December 16, 2020**  
**Town Board Meeting at the Historic Scott House**  
**5:30 p.m.**

Board Chair Diane Felde-Finke opened the meeting at 5:30 p.m. Other board members present: Supervisor John Vernon, Supervisor Randy Willie, Treasurer Ginny Vernon, Clerk Sue Chapin. Also present: Road Foreman Bob Olean.

**MOTION to approve the December 2, 2020 minutes as printed was made by Willie and seconded by J. Vernon; all voted yes, the motion passed.**

**MOTION to pay all bills, check numbers #17523 - #17541 and electronic payment PERA20DEC for the total amount of \$79,933.12 was made by Willie and seconded by J. Vernon; all voted yes, the motion passed.** Check #17524 was voided.

G. Vernon presented the treasurer's report.

Discussion on interest rates available at RBC as compared to Frandsen. The interest rates at Frandsen are .25% for savings and .26% for checking. RBC is at .01% for cash accounts.

**MOTION to transfer \$294,315.59 in the Sewer/Repair Fund from RBC to our Frandsen Savings Account was made by Felde-Finke and seconded by J. Vernon; all voted yes, the motion passed.**

**OLD BUSINESS**

- Water Line: There will be a utility meeting sometime in January. David Bolf with NCE and Susan Wojtkiewicz with Donohue would like to meet with the board to go over an agreement on NCE's water line inspection work. Jessica Cook with Ehlers would like to meet with the board to go over the water rate study. A special meeting will be set for January 6 to discuss those items. Felde-Finke and the Clerk will participate in another phone conference with people from Ehlers, Kennedy & Graven, and Donohue on December 18.

- WLSSD: WLSSD has extended their hold on sump pump and lateral inspections until July 1, 2021.
